

Appendix G. Non-Hazardous Waste Disposal Documentation Site 107, Garfield Avenue Group PPG Jersey City, New Jersey

This appendix includes bills of lading (BOLs) for non-hazardous wastes which were removed during implementation of the remedial action for the Majority Area Soil (AOC-1A) at the Hudson County Chrome (HCC) Site 107, Jersey City, New Jersey. The excavation of the Majority Area Soil at HCC Site 107 occurred concurrently with remedial excavation on the adjacent HCC Site 108, the Consolidated Rail Company right-of-way and the Site 067 utility easement; therefore, a portion of non-hazardous waste generated on these properties are also included in this appendix. As such, BOLs are identified based on waste stream and organized by disposal facility (**Table 1**):
