

## Appendix H. Hazardous Waste Disposal Documentation Site 107, Garfield Avenue Group PPG Jersey City, New Jersey

This appendix includes manifests for hazardous wastes which were removed during implementation of the remedial action for the Majority Area Soil (AOC-1A) at the Hudson County Chrome (HCC) Site 107, Jersey City, New Jersey. The excavation of the Majority Area Soil at HCC Site 107 occurred concurrently with remedial excavation on the adjacent HCC Site 108, the Consolidated Rail Company right-of-way and the Site 067 utility easement; therefore, a portion of hazardous waste generated on these properties are also included in this appendix. As such, manifests are identified based on waste stream and organized by disposal facility (**Table 1**):

The majority of the wastes were shipped off site via tri-axle dump trucks and some of these wastes were transferred into rail cars/gondolas at transfer stations for transport to their final destination. In some instances, the accompanying manifests were not "corrected" with final weights or improperly "corrected" to reflect the total combined weight for the rail car/gondola at the receiving facility. The weights presented in this table are consistent with the final recorded weights from the disposal facility.
